FY 2017 Media Training Requirements

Summary

The State Department's Public Affairs Bureau Office of International Media Engagement (PA/IME) conducts on-camera media training for U.S. Chiefs of Mission, spokespersons, senior officials, and other staff at U.S. Embassies and offices who are required to engage with journalists. The U.S. Africa Regional Media Hub based in Johannesburg is responsible for training in sub-Saharan Africa and for the upcoming year has prioritized four Missions for training: U.S. Embassy Kampala, U.S. Embassy Monrovia, U.S. Embassy Abidjan, and U.S. Embassy Khartoum.

Media Training Activities

Experienced media professionals and seasoned journalists are required to conduct practice media interviews with the Chief of Mission and senior staff (as designated) of the target U.S. Embassies, as well as development of messages and positioning, and stakeholder interview skills. During two full working days in each country, the contractor must conduct multiple mock interviews with each participant, including feedback, on formats that may include: print interview, telephone interview, face-to-face radio interview, face-to-face TV interview, and Down-the-line TV interview. Depending on the selected format, length, and number of participants, the agenda for each day may vary in order to meet the needs of the Mission.

The training modules for each country must include and understanding of how the media works, preparation for different topics, including policy or crisis, key messaging, interview tactics, and dealing with contentious topics. It is vital that media training for U.S. official spokespersons effectively impart branding, memorable delivery, and how to bridge from questions to talking points. Feedback must include the range of tangible and intangible elements of an interview from tone to appearance to control and body language.

Tailored to each country and the U.S. foreign policy interests in that country, the development of messaging and positions must be imparted by the contractor in order to help the Country Team refine their key messages for their audience. This element of the training must include well-established techniques in crafting a message structure to suit the determined objectives.

The training must also cover techniques for continuous improvement and practice in building stakeholder interview skills, to include clarity, avoiding jargon, and other media engagement best

practices. Thorough feedback from the trainers will be expected for each participant, productively offering ideas and guidance to improve performance.

Key learning points to be covered with each participant must include: level of preparation, key message delivery, and degree of control, body language, voice, confidence, strong sound-bites, and avoiding traps.

The media coaching must be relevant to U.S. foreign policy and strategic interests in Africa, including those unique to each of the four Missions

Training Dates

Based on the availability of Chiefs of Mission and other Embassy staff, training dates are fixed long in advance and are generally not flexible:

U.S. Embassy Kampala October 27-28

U.S. Embassy Monrovia November 17-18

U.S. Embassy Abidjan November 29-30 (to include in-language in French)

U.S. Embassy Khartoum January 2017 (to include in-language in Arabic)

Other Requirements

Media training, including skills development, audience analysis in each market, and strategic communications, must be tailored to advancing U.S. national interests in each country.

Thorough pre-training questionnaires should be provided to each of the four Posts to assist in tailoring the effort and in order to provide materials for preparation. Comprehensive post-training feedback must also be provided to each participant so that each individual can continue to build their media engagement skills set. The contractor must provide all required equipment to conduct training.

The Contractor shall comply with the provisions of this paragraph (d) if this contract was awarded using other than sealed bid, is in excess of the simplified acquisition threshold, and does not contain the clause at 52.215-2, Audit and Records—Negotiation.

(1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

(e)(1) Notwithstanding the requirements of the clauses in paragraphs (a), (b), (c), and (d) of this clause, the Contractor is not required to flow down any FAR clause, other than those in this paragraph (e)(1) in a subcontract for commercial items. Unless otherwise indicated below, the extent of the flow down shall be as required by the clause—

(i) 52.203-13, Contractor Code of Business Ethics and Conduct (Apr 2010) (41 U.S.C. 3509).

(ii) 52.219-8, Utilization of Small Business Concerns (May 2014) (15 U.S.C. 637(d)(2) and (3)), in all subcontracts that offer further subcontracting opportunities. If the subcontract (except subcontracts to small business concerns) exceeds \$650,000 (\$1.5 million for construction of any public facility), the subcontractor must include 52.219-8 in lower tier subcontracts that offer subcontracting opportunities.

(iii) 52.222-17, Nondisplacement of Qualified Workers (May 2014) (E.O. 13495). Flow down required in accordance with paragraph (l) of FAR clause 52.222-17.

(iv) 52.222-26, Equal Opportunity (Mar 2007) (E.O. 11246).

(v) 52.222-35, Equal Opportunity for Veterans (Sep 2010) (38 U.S.C. 4212).

(vi) 52.222-36, Affirmative Action for Workers with Disabilities (Oct 2010) (29 U.S.C. 793).

(vii) 52.222-40, Notification of Employee Rights Under the National Labor Relations Act (Dec 2010) (E.O. 13496). Flow down required in accordance with paragraph (f) of FAR clause 52.222-40.

(viii) 52.222-41, Service Contract Labor Standards (May 2014) (41 U.S.C. chapter 67).

(ix) 52.222-50, Combating Trafficking in Persons (Feb 2009) (22 U.S.C. 7104(g)).

—Alternate I (Aug 2007) of 52.222-50 (22 U.S.C. 7104(g)).

(x) 52.222-51, Exemption from Application of the Service Contract Labor Standards to Contracts for Maintenance, Calibration, or Repair of Certain Equipment-Requirements (May 2014) (41 U.S.C. chapter 67).

(xi) 52.222-53, Exemption from Application of the Service Contract Labor Standards to Contracts for Certain Services-Requirements (May 2014) (41 U.S.C. chapter 67).

(xii) 52.222-54, Employment Eligibility Verification (AUG 2013).

(xiii) 52.225-26, Contractors Performing Private Security Functions Outside the United States (Jul 2013) (Section 862, as amended, of the National Defense Authorization Act for Fiscal Year 2008; 10 U.S.C. 2302 Note).

(xiv) 52.226-6, Promoting Excess Food Donation to Nonprofit Organizations (May 2014) (42 U.S.C. 1792). Flow down required in accordance with paragraph (e) of FAR clause 52.226-6.

(xv) 52.247-64, Preference for Privately Owned U.S.-Flag Commercial Vessels (Feb 2006) (46 U.S.C. Appx. 1241(b) and 10 U.S.C. 2631). Flow down required in accordance with paragraph (d) of FAR clause 52.247-64.

(2) While not required, the contractor may include in its subcontracts for commercial items a minimal number of additional clauses necessary to satisfy its contractual obligations.

(a) The Contractor shall comply with the Department of State (DOS) Personal Identification Card Issuance Procedures for all employees performing under this contract who require frequent and continuing access to DOS facilities, or information systems. The Contractor shall insert this clause in all subcontracts when the subcontractor's employees will require frequent and continuing access to DOS facilities, or information systems.
